



Updating NFHP Bylaws

- ACE Act Reauthorization (through 2030) was signed into law December 2024.
- Reauthorization requires an update to the NFHP bylaws.
- Board Tab 8 includes the revised, track changes version of the NFHP bylaws.

Updating NFHP Bylaws

- NFHP Bylaw revisions include changes to:
 - Board membership
 - Quorum and voting numbers based on total membership changes
 - Board reporting requirements
 - Technical and scientific assistance funds section
 - EXCOM role of discussing and voting on Board budget items
