The National Fish Habitat Board meeting commenced with a warm welcome and appreciation for attendees' time and commitment. Special thanks were extended to Pat Rivers and the Minnesota Department of Natural Resources for hosting, and to Kelly Wilder for facilitating the Fish Habitat Partnership workshop. Board members introduced themselves and were encouraged to provide feedback throughout the session. Primary discussions will be held among board members, with occasional input from the audience. Participants were asked to raise their hands, either in person or virtually, to contribute. The agenda for the meeting was reviewed and approved, and the notes from the June Board meeting were formally approved.

Alex presented remotely and shared the upcoming Board meeting schedule, as outlined in Board book tab 2. She noted a change in the date for the final 2025 virtual meeting, which is scheduled for November 18 from 1–5 PM ET. The first Board meeting of 2026 was planned as an in-person gathering on January 28–29 at Table Rock Lake, Missouri, home of Bass Pro Shops. Additional 2026 meeting dates were still to be determined and were expected to be announced during the November meeting, with tentative plans for a virtual session in late April or early May, an in-person meeting in the last week of July, and another virtual meeting in the first week of November.

Board awareness of the role of the fishing industry and the Sport Fish Restoration Program to fish habitat conservation.

Steve Quinn and Craig Kelling briefed the Board on the Sport Fish Restoration Program and its ties to the fishing industry. Steve Quinn, a hall of fame angler and former regional fisheries biologist, emphasized the importance of partnerships, media engagement, and community involvement through initiatives like the Black Bass Symposium (NEXUS), Pro Bass Tournaments, Friends of Reservoirs raffles, and Bass Pro's round-up program. He also highlighted emerging threats to water quality—including pharmaceuticals, microplastics, PFAs, 6PPD quinone from tires, and boat wakes and stressed the need for innovative solutions like filtration devices and broad collaboration. Craig Kelling, from the USFWS Office of Conservation Investment, celebrated the 75th anniversary of the Sport Fish Restoration Act, which has allocated approximately \$19 billion to states since 1950 through excise taxes on fishing equipment. He shared success stories such as over 1 billion fish stocked annually, 320+ hatcheries operated, and restoration of more than 1.2 million acres of inland habitat. Kelling also described the Partner with a Payer Program, which connects manufacturers with state agencies through filmed events available online. The discussion included ideas for expanding outreach, developing toolkits, creating consistent messaging, and producing a NFHP Partner with a Payer video next field season. Emphasis was placed on improving water quality education, showcasing community impacts, and leveraging platforms like social media and podcasts.

Simen Kaalstad (Atlantic Coastal Fish Habitat Partnership) presented, on behalf of FHPS, the outcomes

of the FHP workshop held over the previous 1.5 days. Facilitated by Kelly Wilder of the Minnesota DNR—who played a key role in developing the agenda—the workshop focused on relationship building and peer learning among coordinators, exploring strategies for resilience in a changing operational environment, strengthening connections between FHPs and the National Fish Habitat Board, and maximizing the collective impact of NFHP and its partnerships. Key themes included enhancing capacity and collaboration, improving communications and outreach, advancing funding and resource development, integrating science, data, and landscape planning, and elevating Tribal engagement. Appreciation was expressed to Kelly Wilder for her facilitation, which enabled staff to fully engage in the workshop.

Joe Nohner will presented on the Midwest Glacial Lakes Partnership (MGLP), the Fish Habitat Partnership (FHP) he coordinates spanning nine states and engaging over 3,000 partners. With an estimated \$21.1 billion in economic impact, MGLP addresses key challenges such as watershed degradation, shoreline loss, water quality decline, and fish passage barriers. The partnership supports a wide range of initiatives—including on-the-ground projects, assessments, education and outreach, and a practitioner forum—with notable efforts at Lake Lizzie and Prairie Lakes (MN), Pickerel Lake (SD), Fish Sticks (WI), and the Wawasee Inlets Nutrient Study (IN). MGLP's funding impact includes a \$5 million America the Beautiful project, and its science contributions span aquatic vegetation assessments, climate change planning, and published research. Outreach efforts are robust, with 125,000 copies of the Shoreline Living publication distributed (funded by MSCG), a Contractor Tip Sheet/Brochure, and a webinar series that has hosted 54 events since 2019, drawing 3,800 attendees and 6,200 YouTube views.

David Miko attended virtually to share updates from the U.S. Fish and Wildlife Service, including the latest budget figures, FY2026 project list, and program implementation progress. He discussed the interagency fish passage task force and highlighted plans for America's 250th anniversary, which aimed to promote outdoor access nationwide—such as free youth fishing in Washington, D.C. during the 2026 Capitol Cast event. Miko also introduced new staff under the incoming Director, many of whom hailed from the western U.S. Budget discussions included a continuing resolution of \$1.68 billion, a presidential proposal of \$1.14 billion, and anticipated reductions from both the House and Senate, though the NFHP budget remained stable and the Appropriations Bill was still uncertain. FY2026 projects were expected to be signed by the Secretary before September 25. Expansion of



NFHP was ongoing, though the SFBCP remained paused due to an unsigned charter and a vacant seat, with no timeline available. He also reported on the pending \$26 million Recreational Boating & Fishing Foundation Outreach Grant, which received 200 proposals from 170 entities across 21 states, totaling \$500 million in requests, with awards anticipated by the end of the calendar year.

Dave Smith shared the evolution and success of the joint venture (JV) model as an alternative approach to funding conservation work. Unlike the NFHP model, JV funding—approximately \$300K per venture—was strategically redirected from on-the-ground projects to hiring staff who then successfully secured grants from NRCS, BLM, and USFS. Since its inception, the JV grew from 2 fulltime staff to 17 FTEs and jointly supported an additional 45 positions at NGOs and partner agencies through external funding. In 2007, the JV operated with 4.5 FTEs, a \$890K budget, and a 9-member Board, allocating \$310K annually to projects. Over time, it eliminated its habitat program to focus on strategic capacity building and recruited state directors to strengthen its leadership. Between 2012 and 2016, the JV facilitated \$295 million in on-the-ground conservation, notably through sage grouse efforts. By 2025, the JV had expanded to a \$6.75 million budget, a 19-member staff (including 2 PhDs and 3 communications specialists), and 46 field capacity positions—most employed by WAFWA, with only two federal staff. The JV's work encompassed field delivery, science-to-implementation, strategic communications, partnership development, and government relations. A \$100K investment in staffing typically yielded \$1 million in conservation funding. Board recruitment from the private sector brought valuable connections, including two planned DC fly-ins in 2025. Growth was driven by partner contributions, and agency missions were integrated through joint management of field capacity roles. Smith's presentation offered the NFHP Board a compelling example of how appropriated funding could be leveraged for landscape-scale conservation.

The second day of the NFHP Board meeting began with a warm welcome and reflections on the previous evening's social time, which offered valuable opportunities for Board members and FHP coordinators to connect. The agenda was full, and it was noted that the Vice Chair, Stan Allen, would take over meeting facilitation following the afternoon break. Discussions included Dave Smith's presentation and subsequent conversations with federal partners about identifying and filling strategic gaps in conservation efforts. The importance of Board members and their roles was emphasized, along with the potential for a "Partner with a Payer" model to support multiple FHPs—an idea Tim planned to explore further with Tom. The group also reaffirmed its commitment to promoting NFHP's mission and visibility, particularly through engagement with AFWA.

Jason and Alex presented an overview of the draft third edition of the NFHP Action Plan, inviting Board discussion, questions, and feedback. The full draft was scheduled to be distributed via email following the meeting for written comments. The presentation acknowledged the contributions of the drafting team—Jason Olive, Gene Gilliland, Adam Ringia, Steve Perry, Pat Rivers, Ian Nakayama, Lori Maloney, Holly Steindorf, and Todd Ewing—who helped shape a bold vision for NFHP's next five years. Discussions focused on national leadership and coordination, including the role of the National Conservation Priorities (NCP), the scope of the Interagency Task Force, and the integration of regional AFWA efforts and State Wildlife Action Plans. Board members debated goal timelines, growth metrics, and the importance of maintaining priorities. Advocacy strategies were explored, with suggestions to elevate NFHP's visibility within broader federal fish habitat programs and upcoming legislation like the Farm Bill. The group considered ways to mobilize support, including stewardship pledges, field visits tied to reauthorization, and enhanced communications through partner events and media engagement. Recommendations were made to ensure FHPs have bi-directional communications plans and to incorporate annual feedback into national workplans. The Board also discussed representation



from commercial and recreational fishing sectors, proposing goals for coastal and marine FHP steering committees and exploring metrics to evaluate stakeholder engagement. Under the goal of achieving measurable, science-based outcomes, members emphasized the importance of regular strategic plan updates, hosting workshops, and maintaining a best practices hub. The potential development of a socioeconomic calculator was noted, pending external funding. While the draft was not yet public, it was deemed appropriate to share with individuals engaged in national-level conservation strategy.

Jake Slager, as the new Chair of the Communications Committee, shared the Committee's planning progress and vision for celebrating the NFHP 20th Anniversary. The proposed multimedia campaign aimed to elevate awareness and recognition of NFHP's mission to protect, restore, and enhance fish habitat through in-person events, site tours, social media engagement, advertising partnerships, and commemorative materials. Planning included a 2026 events calendar featuring regional association gatherings, national seafood events, state free fishing days, and billfish tournaments. The Committee brainstormed promotional ideas such as a 20th anniversary logo, posters, tote bags, digital products with QR codes, and a coordinated social media campaign. They explored advertising opportunities in state fishing regulations and agency digests, and emphasized the importance of timing for print deadlines. Additional ideas included honoring original NFHP members monthly, hosting a virtual founders' discussion in April 2026, and recognizing contributors through the Stan Moberly Award and a proposed Habitat Hall of Fame. The Committee also discussed corporate donation challenges, newsletter content, and a potential congressional designation of a fish habitat day, month, or year. A new Instagram account was launched to showcase FHP projects, and MeatEater pledged a \$500 contribution in exchange for media and trivia engagement. The Board was encouraged to review the FHP toolkit and consider how evolving technologies might shape future outreach.

Gary and Jason shared the proposal concept for "NFHP Communications," which was being prepared for submission under the 2025 Multistate Conservation Grant (MSCG) process, with applications due to AFWA by September 22. The proposal, to be submitted by Beyond the Pond on behalf of the NFHP Board, included funding requests for website and communications support for both NFHP and Beyond the Pond, as well as printing and publishing costs for the 2026 NFHP Action Plan. The budget breakdown included \$10K for the Action Plan, \$16K for the NFHP website, \$4K for the Beyond the Pond website, and \$34K for indirect and administrative costs. Questions were raised about the award range and the lack of a contingency plan if funding was not secured, particularly for the Action Plan. Separately, AFS planned to submit a proposal on behalf of the Science and Data Committee to support the remaining work on the 2025 National Fish Habitat Assessment, with \$228K requested and \$260K already allocated in the FY26 budget. The group acknowledged that AFWA administers sportfish restoration funds annually, prioritizing projects that benefit multiple states.

Local Fish Habitat Partnerships (FHPs) from the Midwest region gave brief presentations highlighting their conservation priorities and regional challenges. The Driftless Area Restoration Effort (DARE) emphasized its role as a focal landscape partnership encompassing 3,600 trout streams and rooted in grassroots collaboration since 2004. DARE showcased its scientific contributions—including an annual symposium, shared conservation priorities, and a rangewide brook trout assessment—alongside its \$1.6 billion economic impact from trout fishing. Restoration efforts such as Fancy Creek relied heavily on NRCS support, and outreach initiatives included youth engagement and the WiseH2O mobile app for water quality monitoring. Over the past three years, DARE secured \$4 million in non-NFHP funds and \$65 million in federal funding over 16 years. The Fishers and Farmers Partnership, founded in 2008, highlighted its active Steering Committee structure, with agricultural and river partners in each state and three co-leads. Their work focused on soil health, landowner engagement, and storytelling, supported by \$2.2 million from NFHP and \$8 million in leveraged funding. They hosted locally tailored workshops and encouraged the Board to place greater emphasis on social engagement in future evaluations.

Todd Ewing (virtual) and Jason Olive presented a proposal to transition the barrier inventory and prioritization tool—along with its staff—from being housed under the Southeast Aquatic Resources Partnership (SARP) to the national NFHP framework. This shift was intended to better reflect the tool's national scope and elevate NFHP's visibility within the fish passage community. The Barrier Prioritization Inventory, developed by Kat Hoenke and enriched with data from NAACC and UMass Amherst, has evolved into a nationally recognized resource, with 43% of SARP-NFHP projects over the past five years focused on barrier-related work. Kat would join the NFHP Board staff, with funding secured through 2026 and part of 2027. The proposal received support from long-time partner Nat Gillespie at USFS and was positioned as a candidate for agency scientific and technical assistance funding. However, concerns were raised about the need for a backup funding plan should grant support not materialize.

Julie Carter, the new Chair of the Beyond the Pond Board, shared updates on the Board's ongoing reform efforts. Since meeting in late July, the Board established an Executive Committee, aligned its term structure with the NFHP Board, and began updating bylaws and administrative processes. Therese Thompson has been contracted as program coordinator since early 2025, and the				

organization's banking arrangements were revised to begin earning interest. The Board remained



short two members and planned to schedule listening sessions with FHP coordinators to strengthen engagement. Additional initiatives included creating one-pagers to highlight FHP projects, developing guidance for using Beyond the Pond as a fiscal agent, and improving systems for tracking grants and sponsorships. Jesse was scheduled to join the October 8 FHP call, and a more comprehensive update was anticipated at the January 2026 Board meeting. Julie also expressed appreciation to Ryan for his decade of leadership with Beyond the Pond.

Jared Ross and Megan Malish provided an update on the 2025 National Fish Habitat Assessment, which we can expect a draft by the end of the year. The assessment incorporated a landscape-scale approach and individual species analyses, building on lessons learned from the 2015 version. Notably, the two assessments are not directly comparable due to methodological improvements—such as the inclusion of previously overlooked disturbances and efforts to make outputs more interpretable and actionable. The 2025 assessment drew on data from 84 providers and covered approximately 51,000 stream reaches, with expanded focus on land use, habitat fragmentation, and water quality barriers. It also aimed to identify limiting disturbances that trigger negative threshold responses in fish populations. Looking ahead, future iterations may incorporate stream temperature data, and coverage will expand to include Alaska, Hawaii, and Puerto Rico in the coming year.

Stan Allen presented two draft Standard Operating Procedures (SOPs) developed for inclusion in the NFHP procedures manual. One SOP detailed the annual fish habitat conservation project evaluation process, while the other outlined the steps for considering the designation of a new Fish Habitat Partnership. Both drafts were included in the Board book for review, with final approval scheduled for the next Board meeting. Board members were encouraged to send comments to Stan and Jason by October 15 to ensure feedback could be incorporated ahead of the vote.


