

IMPORTANCE OF NFHP PROJECT TRACKING SYSTEM

NFHP Project Tracking System

- Data exchange between Board, FHPs, and all partners
- Online data entry, editing, searching, and reporting
- Map project locations
- Share accomplishments of the NFHP program
- Can be expanded and modified as the national program and the partnerships evolve


Efficiency of NFHP Partnership Performance Evaluation Process

 Generate project-specific questions (questions 1-4) automatically from the database



OVERVIEW OF SYSTEM

- SQL Database
- Web-based data entry interface
 - Unique logins for each partnership.
 - Data entry
 - Queries
 - PDF reports





CHALLENGES

Database

- USWFS FIS Data
 - Quality of FIS data is variable across FHPs
 - No location information (limited mapping capabilities)
- Reports highly dependent on quality of data
- Database field improvements
 - Can be more in line with reporting needs.

Online System

- Original design focused on data entry over summary outputs and mapping functionality
- Limited ability to fix bugs




